**DISCLAIMER****PRODUCER'S COMMITMENT**

On behalf of Dare 2 Dream Alpaca Farm & Sandy Loam Produce, and under the CSA formula, I agree to provide, at long season (15 weeks) a variety of vegetables and fruits, high quality, grown and cultivated with our farming practices.

I guarantee that all plant products of the farm are grown organically, although not certified. We use methods beyond organic standards to ensure the highest quality in the food provided. Since we started our operation, no chemical fertilizers or pesticides/herbicides have been used.

I commit to implementing all necessary means to provide a satisfactory share of the harvest.

I commit to transporting the produce to the selected points of delivery on time.

I will be available to answer question on the farm, farming methods, or any other issue pertaining to the working of the farm.

I undertake to deliver the CSA baskets for 15 consecutive weeks (if permitted) between early-July to mid-October. CSA share partners will receive an email and/or text notification 4 days prior to first delivery of the season. A similar notification will be made for changes in the supply or delivery time.

Farming is at the mercy of Mother Nature. If any issue arises that interferes with delivery of the contracted produce, I will use all means necessary to compensate by extending the supply season with late crops.

**CSA SHARE PARTNER'S COMMITMENT**

I am committed to this season to receive a basket/box of farm products, according to the products availability, the size of the basket/box selected, frequency and place of delivery agreed in this Agreement.

I will prepay the CSA share type I have chosen to contribute to the financing of this community supported agriculture (CSA) project.  
*(must be paid in full by June 1<sup>st</sup>, 2016)*

I accept the risks and benefits of the CSA formula. I understand that agricultural products are dependent on many factors outside the control of the producer and I accept that the farmer will do his/her utmost to supply the agreed upon harvest in quantity, quality and variety described, and substitute and/or lengthen the contract to compensate for weather or growing season concerns.

I pledge to be at the chosen place of delivery at the agreed time, or contact the farm in advance if I intend to go to the farm stand for pick up. If I am absent for any reason, I will advise the farm 2 days before to arrange an alternative pick up or delivery, otherwise I will assume the loss.

I agree that under the CSA formula, the producer will put into baskets/boxes the produce available at the farm at the time of delivery.

The number of partners is limited; I agree that the receipt of payment will confirm my reservation.

I agree to a preferred for communication and I will regularly check for messages from the farmer.
